Ms. Thiel is an architectural historian and the owner of Clifton Historic Resources, LLC, a Woman-Owned Business Enterprise (WBE) certified architectural history and cultural resource management consulting firm based in Tennessee. She exceeds the requirements in 36 CFR 61 for Architectural History, having worked in the field of architectural history since 2005 having authored or co-authored nearly 300 various types of reports including historical and architectural research, architectural surveys, NRHP nominations, historic contexts, Section 106 reviews, and cultural resources surveys assessing NRHP eligibility of historic resources.

Ms. Thiel has authored NRHP nominations in Tennessee and Arkansas, including individual properties and historic districts, prepared for state historic preservation offices (SHPOs), municipalities, and private owners. Her nomination work encompasses all phases of the process, from initial eligibility assessment and archival research through fieldwork and photography, preparation of the registration form to NR Bulletin 16A standards, response to SHPO and NPS review comments, and presentation before state review boards. She also has extensive experience conducting Section 106 reviews for various federal and state agencies, including direct project experience with various districts for the U.S. Army Corps of Engineers (USACE), the Federal Communications Commission, multiple Departments of Transportation, the Department of Defense, the National Park Service, as well as private organizations and local government agencies. She is well-versed in NRHP eligibility criteria, 36 CFR Part 800 of the National Historic Preservation Act, Section 4(f) evaluations, adverse effect determinations, and Memoranda of Agreement. She has completed a high volume of architectural/historical assessments for various departments of transportation and civil engineering firms that included determinations of NRHP eligibility and assessment of effects. Ms. Thiel manages all aspects of architectural history projects including project proposals, budgets, fieldwork, archival research, and field production. Her scholarship has appeared in peer-reviewed publications, including a forthcoming article in *Arris*, the journal of the Southeast Chapter of the Society of Architectural Historians (SESAH), and authoring and coauthoring fifteen architect and builder biographies contributed to *North Carolina Architects & Builders: A Biographical Dictionary* (North Carolina State University Libraries).
